# **Federal & State Rules**

Rule 23 of the Federal Rules of Civil Procedure governs class actions. Annotated discussion is available in the *Federal* Civil Rules Handbook. In addition, most states have adopted their own class action rules, often based on the Federal rule. Other states may base their rule on the 1976 Uniform Law Commissioners' Model Class Actions [Act] [Rule]. For more information on the model rule, please see volume 12 of *Uniform Laws Annotated*.

Massachusetts class actions are governed by Rule 23 of the Massachusetts Rules of Civil Procedure, which are available in Massachusetts Rules of Court: State.
